
## Mission





#### EGRACONS — European Grade Conversion System

#### January 2012 – December 2015

The EGRACONS tool is a free, user-friendly web-based tool for grade conversion available to all European HEIs (and beyond) who supply their degree grade distribution tables. It enables a transparent interpretation of student achievements abroad.



#### <u>UNICAH – Strategic Partnership for the Implementation of the University</u> International Cooperation and Humanitarian Action Network

#### November 2015 – June 2018

Preparing competitive professionals of the humanitarian sector able to implement change-making processes towards a more inclusive, respectful and fair global society, and fostering research and innovation in the field of international cooperation for the humanitarian professional sector.





## Past External Projects





#### **EWP / EWP 2.0.** – Erasmus Without Paper / Erasmus Without Paper 2.0. November 2015 – October 2017 / January 2018-December 2019

Bringing the Erasmus administration into the 21st century by going digital: replacing a paper-based workflow by a digital one, tackling the administrative workload for students and staff, creating free public infrastructure and streamlining technical solutions for student mobility.



#### **EVOLVE** - Evidence-Validated Online Learning through Virtual Exchange November 2017 – May 2020 (Postponed to December 2020)

EVOLVE mainstreams Virtual Exchange (VE) in HE by upscaling it to a collaborative international form of learning.







## **Current** External Projects



#### **Rec-Mat** - Recognition Matters

#### October 2017 – October 2020 (Postponed to October 2021)

The RecMat project aims at facilitating and promoting student exchanges between Europe and Latin America by reducing the barriers to mobility in the processes of academic recognition.



#### **SUCTIA -** Systemic University Change Towards Internationalisation for Academia September 2019 – August 2022

SUCTIA was built on SUCTI, and its aim is also to raise awareness and shift the internal culture of our institutions towards internationalization. This new project focuses in academic staff.







## **Current** External Projects



#### **CalohE2** - Measuring and Comparing Achievements of Learning Outcomes in Higher Education in Europe - Phase 2 January 2020 – December 2021

CalohE2 is a follow-up <u>project of CALOHEE</u>, which aim is to develop an ambitious and sophisticated instrument to measure performance. The actual testing/ assessment is not part of this project.

#### **CalohEx** - Measuring and Comparing Achievements of Learning Outcomes in Higher Education in Europe –Extension January 2020 – December 2022

CalohEx is an extension <u>of the CALOHEE project</u>, considering another five subject areas. Its aim is to develop new instruments for educational reform.



#### **IHES-** Internationalisation in Higher Education for Society

November 2020 – August 2023

Use the knowledge of the different partners on internationalisation and the needs for society to develop, test and assess different approaches of IHES in practical situations, thus also creating a substantial and hands-on manual for universities to implement IHES in every-day internationalisation.
